



BOAT RENTAL AGREEMENT, WAIVER & RELEASE OF LIABILITY

Northwest Voyagers Boat Rental Options



Single Trip Rental – The usage of the agreed upon NWV equipment is for a single trip and possession of the said equipment can extend to several days prior to and subsequent to the agreed upon trip. The fees associated with single trip rental are \$25 for the first day of use and \$5 for each day of the trip thereafter. The renting member may pick up the rental package the day before and return it the day after the date required unless alternative arrangements have been agreed to by a member of the NWV Club Executive.



Monthly Rental – The usage of the agreed NWV equipment is for a single or multiple trips and possession of the said equipment for up to 31 days but not more than 33 days without prior approval. The fees associated with Monthly rental are \$50 for up to the first 31 days and \$5 for each day thereafter. The renting member may pick up the rental package the day before and return it the day after the date required unless alternative arrangements have been agreed to by a member of the NWV Club Executive.



Seasonal Rental – The usage of the agreed NWV equipment for single or multiple trips anytime during the annual NW Voyagers trip schedule with mandatory return of the equipment prior to November 1st of the year in which the equipment is rented. The fees associated with a seasonal rental are \$100 up to November 1st. The renting member may pick up the rental package any time during the paddling schedule and must return it prior to November 1st of said paddling year.

READ BEFORE SIGNING:

Waiver and Release of Liability: This Waiver and Release of Liability covers all activities directly or indirectly associated with the use of Northwest Voyagers Canoe & Kayak Club’s rented equipment. The undersigned expressly assumes all liability that may arise from the inherent risks that arise from the use of the rented Northwest Voyagers Canoe & Kayak Club’s equipment and accepts that canoeing and or kayaking may involve the unavailability of emergency care and any unforeseen circumstances which may entail unavoidable risks of personal injury, loss of or damage to personal property and or even death. I voluntarily choose to participate in the use of this equipment in spite of these risks and hereby assume all risk of injury, disability, death and loss of or damage to one’s own or borrowed property. I fully understand that I will be canoeing and or kayaking at my own risk. I agree to abide by the rules, regulations and or safety warnings of the Northwest Voyagers Canoe & Kayak Club and or its agents as well as any other governing rules and regulations that exist at time of acquisition, delivery, transport or use of said club equipment at any and all trips whether club sanctioned or non-club sanctioned trips.

Terms and Conditions of the NWV Rental Agreement

-  Equipment outlined within the contract may be used for NWV club trips only without purchasing additional insurance. For non-club trips, the undersigned member agrees to provide insurance specifically to cover loss or damage to the rented equipment
-  While using club equipment all parties agree to wear a PFD or life jacket and use all safety equipment at all times when upon the water
-  All NWV club boats come with all government required safety gear as outlined in the following table
-  All rental agreements include an option to exchange type of boat rented, kayak and/or canoe, however the entire existing rental package must be returned at time of exchange unless agreed to by a NWV Executive member
